

CUMBERLAND TAXICAB RATES

Approved by the Maryland Public Service Commission
Effective August 1, 2006

**TAXICAB RATES APPLY TO 1, 2, 3 OR 4 PASSENGERS. THE
MAXIMUM CAPACITY OF A TAXICAB IS 4 PASSENGERS.**

**THE FOLLOWING CHARGES MUST BE COMPUTED BY THE
TAXIMETER:**

- \$1.50** First 1/9 mile or fraction thereof.
- \$.15** Each additional 1/9 mile or fraction thereof.
- \$.10** Each 30 seconds of waiting time.

**IN ADDITION TO THE TAXIMETER RATES, THE FOLLOWING MAY BE
CHARGED:**

- \$.10** Each suitcase, piece of luggage or grocery shopping bag
in excess of one.
- \$.50** Each trunk or foot locker.

**DRIVERS MUST ACCEPT, AND TRANSPORT WHERE DIRECTED,
ANY ORDERLY PERSON, UNLESS PREVIOUSLY ENGAGED.
DRIVERS MAY REFUSE TO TRANSPORT FREIGHT OR LIVE
ANIMALS WITH THE EXCEPTION OF SERVICE ANIMALS (ANY
GUIDE DOG, SIGNAL DOG OR OTHER ANIMAL TRAINED TO WORK
OR PERFORM TASKS FOR AN INDIVIDUAL WITH A DISABILITY).**

**JOINT USE OF TAXICABS BY PASSENGERS OR PARTIES BOUND FOR
THE SAME DESTINATION:**

Drivers may transport more than one passenger or party from one location bound for the same or approximately the same destination. However, no passenger or party who first engaged the taxicab is required to share it with others. Drivers may not refuse service in order to arrange more profitable grouping.

**JOINT USE OF TAXICABS BY PASSENGERS OR PARTIES BOUND FOR
DIFFERENT DESTINATIONS:**

Drivers may also transport more than one passenger or party from one location bound for different destinations. Each passenger or party must be charged the fare recorded on the taximeter upon arrival at each destination. However, no passenger or party may be charged more than the fare applicable for transportation over the shortest and most direct route to each destination.

SOLICITATION:

Drivers may not solicit additional passengers while en route to the destination of the original passenger or party.
